Intended use

DrugWipe® 5+ detects drugs in saliva. The immunoassay test detects cannabis, opiates, cocaine, amphetamines and methamphetamines (ecstasy). The analysis delivers a visible, qualitative result within 10 minutes. We recommend all positive samples are confirmed with a secondary chemical method, e.g. gas chromatography plus mass spectrometry (GC-MS). DrugWipe® 5+ is for single-use per sample only. The test is intended to be used for in-vitro-diagnosis only.

Test principle

DrugWipe® 5+ is based on an immunoassay method. Drug consumption can be detected up to 10 hours in saliva. The sampling of the saliva is carried out with a swab on the tongue or from the interior of the cheeks. The sampling pads transfer the saliva onto the test strips. Drug specific, red stained antibodies are applied on the test strips. If any drugs are present in the saliva sample, the drugs will bind onto these antibodies. DrugWipe® 5+ contains an sealed ampoule filled with a liquid. The test is started when the ampoule is crushed and the liquid released. The liquid carries the antibody bound drugs towards the test line. The test line is visibly stained red for a positive result. The test is valid only when both the control lines are also stained red. The test result is read at 10 minutes.






Analysis

- 1. Check the expiraty date on the foil pack. Discard the test after this date.
- 2. Check the foil pack for damages. If any damage is seen, if moist inside or the control lines are stained red already, discard the test.
- 3. Only open the foil pack at the cut directly before use.







2. Remove the blue sample collector from the white test cassette. Do not touch the sampling pads.



3. Advise the test person to move their tongue around the bottom of the cheek approximately 3 times. With the sample collector wipe the saliva from the tongue or interior cheek with the sampling pads.



4. Place the blue sample collector back onto the white test cassette and press home. Both sampling pads must lock in with an audible double clic.



5. Hold the test cassette vertically with the ampoule at the bottom. Squeeze thouroghly on the word PRESS with the thumb until the ampoule breaks. Hold the test cassette with the ampoule vertical for 10 to 15 seconds.



6. Move the cap back into the starting position. Lay the test on a horizontal surface and commence timing. Read the test result at 10 minutes. Ignore test results before and after.

Test interpretation

Each of the two result windows shows two drug substances and one control line. The abbrevations stand for:

CA Cannabis (THC/Marijuana/Hashish)

AM Amphetamines (Ecstasy/Methamphetamines)

CO Cocaine/Crack

Opiates (Heroin/Morphine)

Control line CL



Negative result = No drug consumption

The test is valid when both control lines (CL). one on each strip, turn red.

The test is negative for drugs when no other red test lines appear.



Positive result = Drug consumption

The test is valid when both control lines (CL). one on each strip, turn red.

The test is positive for a drug, when one or more red test lines appear.



Invalid result

The test is invalid when either one or both the control lines (CL) do not turn red. Repeat the analysis using a new DrugWipe® 5+ test. Control lines (CL)

Notes: The test is also positive, when the test lines are stained faintly or only partially red. In the case of highly positive samples, you may observe visible test lines within three minutes. How ever wait the full ten minutes of test development and then read all the test lines. Test lines stained visibly after the lapse of ten minutes are invalid and should be ignored.

Precautions

- Read the test under sufficient light, e.g. interior light of the car or torch.
- Treat each sample as potentially infectious. During analysis wear single-use gloves.
- Note, red-green colour blindness may have an effect on correct test interpretation.
